- 2) The undersigned (the participants) are the only one authorized to use the laser tag equipment.
- 3) Participation in the above activity is voluntary and may result in (but not limited too) bodily or emotional injury or death, from trips, falls, collisions with other people or objects, diseases or sickness from insects or other forces of nature. You fully acknowledge these risks and dangers and that they may come from unforeseeable causes.
- 4) You fully agree to participate knowing the above in the activities on your site, your location, our location, or any other selected site or location in the state of Massachusetts.
- 5) I, on behalf of myself, my personal representatives and my heirs and my children, understand that if you or any other minors that you are responsible for, are injured or your property is damaged, that you agree to RELEASE, INDEMNIFY, AND HOLD BANANA BILLS LASER TAG HARMLESS FROM SAID INJURIES OR ANY COST OR EXPENSES ASSOCIATED THEREWITH EVEN IF THEY WERE CAUSED BY THE AFFIRMATIVE NEGLIGENCE OF BANANA BILL'S owners, employees, agents, or representatives.
- 6) MEDICAL CONDITION AUTHORIZATION – All participants, regardless of age, certify that I/we have no existing or preexisting medical or physical conditions which may affect their ability to take part in laser tag. In the event there is a problem that was created by any condition you certify that you have adequate insurance or financial means to cover any costs associated by any unforeseen events including but not limited to emergency transportation, medical costs, or any other associated costs.
- 7) RESPONSIBILITY FOR MINORS & AGE VERIFICATION: The undersigned certifies that they are over the age of 18 years. The undersigned also acknowledges that have they have legal authority and responsibility for all minors listed on this document and their ages have been verified before the start of the event.
